Lanford, Jr. hereafter referred to as Grantee, at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the said Grantee, Carl C. Lanford, Jr., his heirs and assigns forever:

ALL that piece, parcel or lot of land in Saluda Township, Greenville County, State of South Carolina, containing approximately 1.04 acres, near Lake Mollirene shown on Plat of Carl C. Lanford, Sr. Estate, dated March 20, 1975, prepared by Carl C. Lanford, Professional Engineer, and recorded in Plat Book 58 at Page 9 in the R.M.C. Office for Greenville County, and having the following courses and distances, to-wit:

BEGINNING at an iron pin on the south edge of a dirt road along the south side of Lake Mollirene and running thence S. 6-15 W. 258 feet to an iron pin; thence N. 83-45 W. 250 feet to an iron pin on east side of a dirt road; thence along said road N. 28-15 E. 162.5 feet to an iron pin; thence along said road N. 58-52 E. 163 feet to an iron pin; thence along said road N. 87-45 E. 59.7 feet to the point of beginning.

This is a part of the property conveyed to Grantor by deed of Hodges Hightower dated July 27, 1954, and recorded in the Office of the R.M.C. for Greenville County, South Carolina, on August 6, 1954, in Deed Book 505 at Page 389.

This deed is drawn to replace a previous deed of Grantor conveying the identical piece of property to Grantee, such deed having been lost and having never been recorded.
