release unto **JOE HAWKINS ENTERPRISES, INC., its successors and assigns forever:**

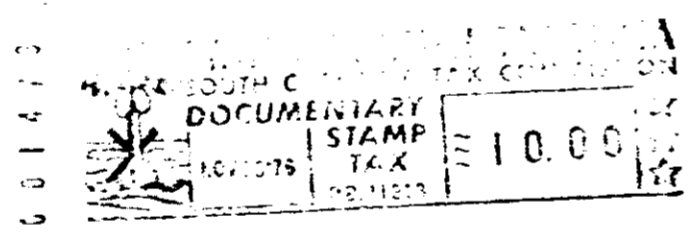
ALL that piece, parcel or lot of land in the County of Greenville,
