release unto William N. Poe and Cynthia N. Poe, their heirs and assigns forever:

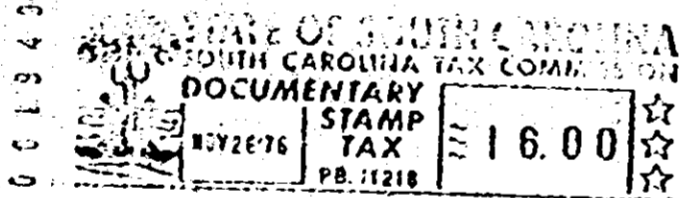
ALL that piece, parcel or tract of land, located, lying and being in the
