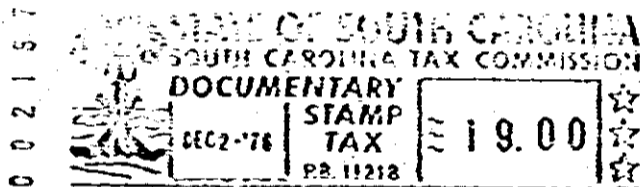
in consideration of Nine Thousand Two Hundred and No/100 (\$9,200.00) ----- Dollars,
