the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto WILLIAM H. McCAULEY

All that piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville and being on the southern side of Roe Ford Road, containing 13.78 acres, more or less, known as property of William H. McCauley, II, as shown on plat recorded in the R.M.C. office for Greenville County in Plat Book 5-2, Page 59 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING in the center of Roe Ford Road approximately 33.3 feet from an iron pin on the southern side of said road and runs thence S. 75-03 W., 33.3 feet to an iron pin; thence S. 75-03 W., 910.9 feet to an iron pin; thence N. 46-02 W., 458.4 feet to an iron pin; thence N. 53-30 E., 1041.1 feet to an iron pin on the southern side of Roe Ford Road; thence N. 53-30 E., 33.1 feet to the center of Roe Ford Road; thence along the center of Roe Ford Road, the chord of which is S. 32-22 E., 317.8 feet to a point; thence continuing along the center of Roe Ford Road, the chord of which is S. 28-03 E., 161.6 feet to a point; thence continuing along the center of Roe Ford Road, the chord of which is S. 23-48 E., 218.1 feet to a point; thence continuing along the center of Roe Ford Road, the chord of which is S. 22-50 E., 99.7 feet to the point of beginning.

LESS, HOWEVER: That portion of property already conveyed to the grantee in Deed Book 877, Page 9 in the R.M.C. Office for Greenville County and being described more fully in Plat Book 4C, Page 73.

This conveyance is made subject to all easements, restrictions and rights of way, if any, appearing of record affecting this property.
