in consideration of Thirty Three Thousand Five Hundred and No/100 (\$33,500.00) Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Richard Kirby Waiser and Nona H. Waiser, their heirs and assigns forever:

ALL of that lot of land in the County of Greenville, State of South Carolina, being shown on Plat of Pine Brook Ext. as a portion of Lot 28 and a majority of the area designated as "Lake", now filled in and a portion of the area covered by the Duke Power Transmission line, recorded in Plat Book W at page 73 and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Cardinal Drive at the southwestern corner of Lot 32 and the power line right of way and running thence along said Drive, S. 25-50 E. 101.6 feet to an iron pin at the corner of Lot No. 33; thence N. 73-06 E. 180 feet to an iron pin at the joint corner of Lots 33 and 37; thence approximately N. 25 E. 130 feet, more or less, to an iron pin at or near the western side of a former lake (said iron pin is located N. 73-06 E. 50 feet from the southeastern corner of Lot 32); and running thence N. 73-06 W. 200 feet, more or less, to the corner of property sold to Grossi in Deed Book 814, page 362 (which iron pin is situated S. 73-06 W. 50 feet from the southwestern corner of Lot 23); thence along the Grossi Property, N. 32-48 W. 84.8 feet to an iron pin; thence N. 26-17 W. 84.8 feet to an iron pin; thence along the property of Roberts, as shown in Plat Book LLL, page 27, in Deed Book 784, page 387, N. 20-52 W. 36.1 feet to an iron pin; thence N. 11-07 W. 100 feet to an iron pin; thence N. 3-52 W. 80 feet to an iron pin; thence N. 2-08 E. 57 feet to an iron pin on the southern side of Runyon Drive; thence with said Drive, along its curve, the traverse of which is approximately S. 33 W. 130 feet, more or less, to an iron pin at the northeastern corner of Lot 28; thence with said Drive S. 27-33 W. 74 feet to an iron pin; thence S. 63-16 W. 36.4 feet to an iron pin, corner of property of Borgschulte, as will appear in Deed Book 523, page 486 and Deed Book 611, pages 411 and 412; thence along his property approximately S. 15 E. 150 feet, more or less to the joint rear corner of Lots 28 and 31; thence along the line of Lot 31, S. 8-12 E. 75 feet to an iron pin; thence along the line of Lot 32, S. 11-30 E. 83.4 feet to an iron pin; thence along the line of Lot 32, S. 73-06 W. 237.6 feet to the point of beginning.
