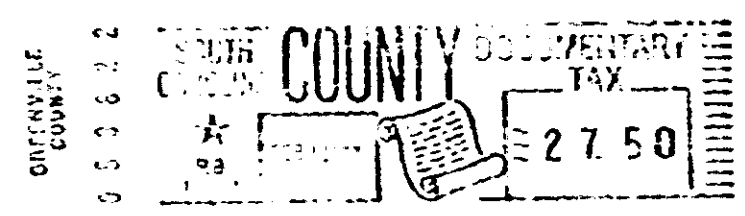

BEGINNING at a point at the corner of Units 103 and 109 and thence running N 39-04 E, 20.7 feet; thence turning and running N 50-56 W, 67.6 feet; thence turning and running S 39-04 W, 20.7 feet; thence turning and running S 50-56 E, 67.6 feet to the point of Beginning.
