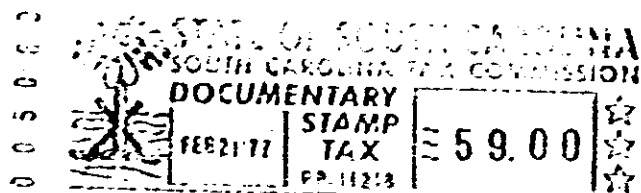
Know All Men by These Presents:

ALL that piece, parcel or lot of land situate, lying and being in the County of Greenville, City of Greenville and State of South Carolina, on the southern side of Tindal Avenue, being shown and designated as Lot No. 28, Block B of property of Cagle Park, Co., as shown on a plat prepared by R. E. Dalton, Engineer, dated July 29, 1915 and recorded in the Office of the RMC for Greenville County in Plat Book C at Page 238, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at a stake on the south side of Tindal Avenue at corner of Lot 27, and running thence with line of Lot 27, S. 0-53 E. 199.8 feet to a point on line of Lot 18, N. 77-44 W. 62.6 feet to stake on line of Lot 16 at corner of Lot 29; thence along line of Lot 29 N. 0-53 W. 185.6 feet to a stake on Tindal Avenue; thence along line of Tindal Avenue N. 89-07 E. 61 feet to the Beginning Corner.
