ALL that piece, parcel or lot of land, being in Pates Township, County & State aforesaid, containing 0.95 Ac., more or less, and according to Plat of Survey prepared by Terry T. Dill, Reg. CEALS No. 104, Route #2, Taylors, S. C., Dated 7/3/75, having the following metes & bounds, to-wit:
