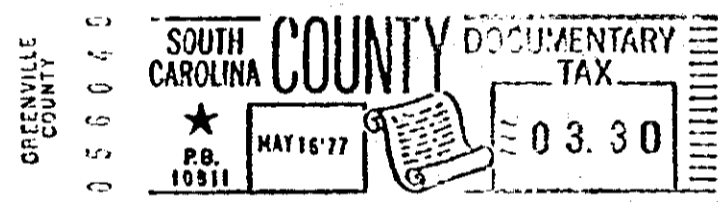
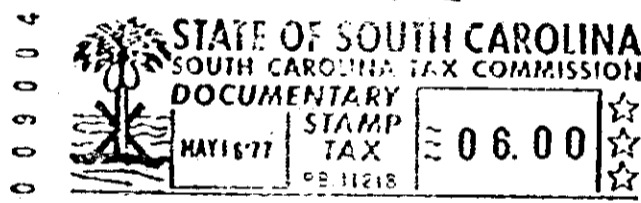
This property is conveyed subject to restrictions, easements, or rights-of-way, if any, of record.
