Charles E. Donaldson and Janice A. Donaldson, their heirs and assigns, forever:

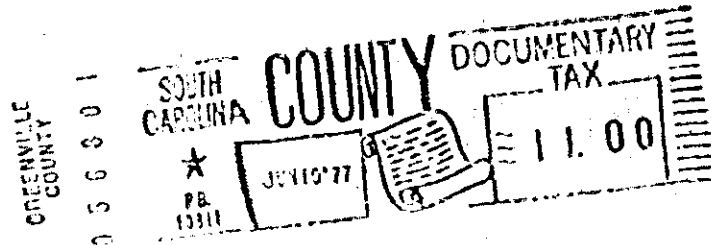
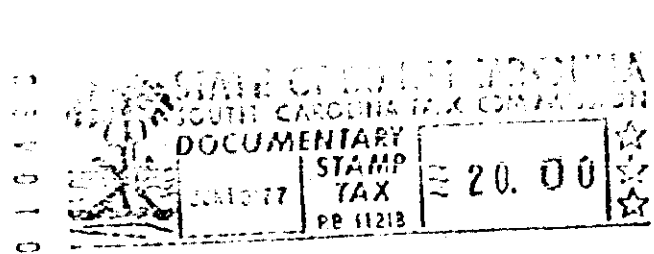
ALL that piece, parcel or lot of land situate, lying and being in the County of Greenville,
