the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

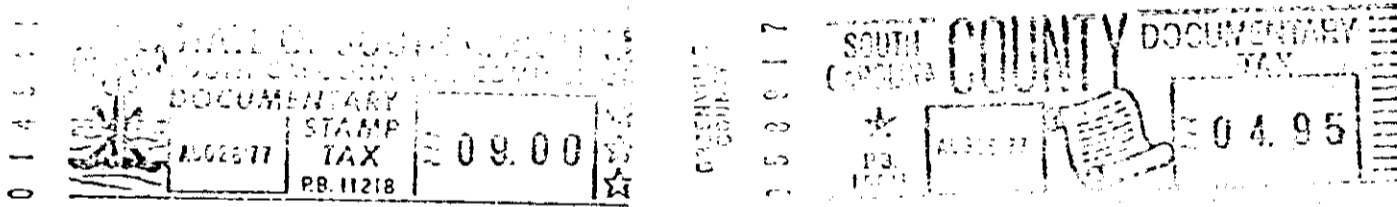
Ernest Aberorombie and Bertha Aberorombie, their heirs and assigns forever:

All of that lot of land in Gantt Township, Greenville County, State of South Carolina, on Kondros Circle, containing one acre and being more fully described as follows according to plat entitled Survey for Ernest and Bertha Aberorombie, prepared by Enwright Associates, Inc., on July 28, 1977, which plat is recorded in the R. M. C. Office for Greenville County in Plat Book 69 at page 62:

BEGINNING at an iron pin on Kondros Circle, joint corner with property of Robert Allen and running thence with the line of Robert Allen, N. 85-43 E. 292.51 feet to iron pin; thence with other property of the grantor herein; S. 14-00 W. 193.68 feet to iron pin; thence with other property of the grantor herein, N. 79-43'-30" W. 278.33 feet to iron pin on Kondros Circle; thence with Kondros Circle, N. 14-00 E. 120 feet to the beginning corner.
