TITLE TO REAL ESTATE

Know All Men by These Presents:

That Harbor Town Limited Partnership, a S. C. Limited Partnership, hereafter referred to as Grantor, in consideration of the sum of thirty-four thousand, four hundred and no/100 (\$34,400.00) -- DOLLARS, paid to Grantor by Ronald E. Lavender and Jean K. Lavender, hereafter referred to as Grantee, at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the said Grantee, their heirs and assigns forever:

ALL that piece, parcel or lot of land in the County of Greenville, State of South Carolina, on the northern side of Stanley Drive, near the City of Greenville, being shown as Unit 57 on plat of Harbor Town, recorded in the R.M.C. Office for Greenville County in Plat Book 5P at pages 13 and 14, and being more particularly described as follows:

BEGINNING at a point at the joint corner of Units 57 and 58, and thence running S. 39-35 W. 20.6 feet; thence turning and running N. 50-25 W. 73 feet; thence turning and running N. 39-35 E. 20.6 feet; thence turning and running S. 50-25 E. 73 feet to the point of beginning.

This is a portion of the property conveyed to grantor by Carla A. Hills, Secretary of Housing and Urban Development by deed dated April 11, 1975, and recorded April 14, 1975, in the R.M.C. Office for Greenville County in Deed Book 1016, at Page 729.

The foregoing conveyance is subject to the terms of that Declaration of Covenants, Conditions and Restrictions, executed by Harbor Town Limited Partnership on January 26, 1976, and recorded in the R.M.C. Office for Greenville County, S. C., on February 6, 1976, in Deed Book 1031 at Page 271.

Grantor hereby agrees to pay 1977 Greenville County property taxes.

The original deed from Harbor Town Limited Partnership to Ronald E. Lavender and Jean K. Lavender, dated July 30, 1977, and recorded on August 1, 1977, in Deed Book 1061 at Page 552, by mistake showed a consideration of \$34,700.00. This deed has been executed to correct that error.
