All that certain piece, parcel or lot of land, with the buildings and improvements thereon, situate, lying and being on the East side of Ivey Street (formerly Goodlett's Alley), in the County of Greenville, State of South Carolina, and having according to plat prepared by C. BEGINNING at an iron pin on the East side of Ivey Street (formerly Goodlett's Alley), joint corner of property now or formerly of Edward J.
