release unto **M. L. LANFORD, JR.**, his heirs and assigns forever:

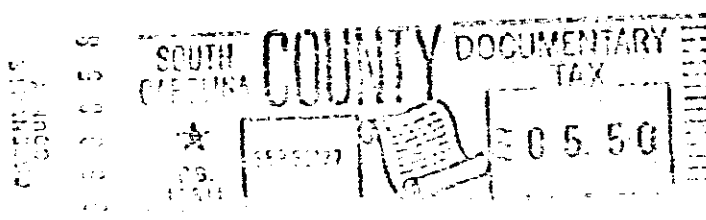
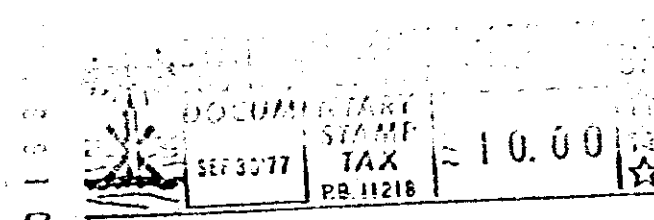
ALL that piece, parcel or lot of land in the County of Greenville,
