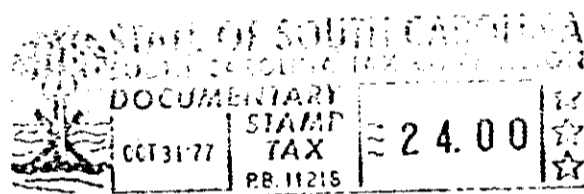
in consideration of Eleven Thousand Eight Hundred and No/100 (\$11,800.00)----- Dollars,

ALL that certain piece, parcel or tract of land situate, lying and being at the intersection of Walker Road and Jackson Grove Road in Greenville County, South Carolina containing 5.9 acres and having the following metes and bounds according to plat entitled "Property of Mildred S.
