pipe; 2 - 6" valves; 6 - 2" valves; and 1 fire hydrant, and is shown on a
drawing entitled "American Service Corporation of S. C. to Commissioners
of Public Works of the City of Greenville, S. C.", dated October 19, 1977,
attached hereto and made a part of this conveyance.
