to said plat.

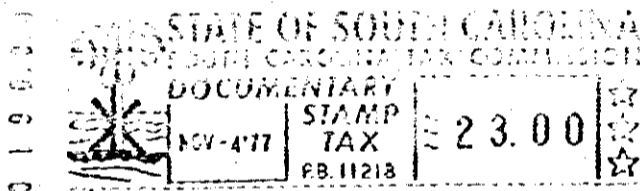
