ALL water lines, mains, valves and appurtenances installed and located in,  
under or along Plantation Dr., Red Oak Ct., and Green View Ct., County of  
Greenville, State of South Carolina, including approximately 2,350 feet,  
more or less, of 12" C. I. pipe; approximately 205 feet, more or less, of  
6" C. I. pipe; approximately 520 feet, more or less, of 2" galvanized pipe;  
2 - 12" valves, to open right; 4 - 6" valves, to open right; 5 - 2" valves,  
to open left; and 3 fire hydrants, to be 3-way and open right, and is shown  
on a drawing entitled "Franklin Enterprises, Inc. to Commissioners of Public  
Works of the City of Greenville, S. C.", dated December 29, 1977, attached
