KNOWN ALL MEN BY THESE PRESENTS, that I, Stephen A. Stokes, Jr.,

in consideration of Eleven Thousand and No/100 (\$11,000.00)-----Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Lamont V. Stokes, his heirs and assigns, forever: All of my undivided interest in and to:

ALL that piece, parcel or lot of land in Chick Springs Township, Greenville County, State of South Carolina, fronting on the Eastern side of a county road leading from U. S. Highway #29, to and across Lee Road, as shown on plat of the property of James M. Edwards, made by R. E. Dalton, Engineer, in February, 1941, and identified thereon as Lot No. 11, and having the following metes and bounds:

BEGINNING at an iron pin at the Southeastern corner of the intersection of said county road and Lee Road, and running thence along the South side of the Lee Road, N. 73-44 E. 201.6 feet to an iron pin, corner of Lot No. 10; thence with the line of Lot No. 10, S. 14-08 E. 105 feet, more or less, to an iron pin, joint rear corner of Lots Nos. 11 and 12, thence with the line of Lot No. 12, S. 76-17 W. 222 feet to an iron pin on the Eastern side of the County road, the joint front corners of Lots Nos. 11 and 12; thence with the eastern side of said county road, N. 1-50 W. 100 feet to the point of beginning.

This is the identical property conveyed to Stephen A. Stokes, Sr. and Birdie C. Stokes by Arnold Brittain and Ethel C. Brittain by deed dated September 8, 1956 and recorded in the R.M.C. Office for Greenville County in Deed Book 561 at Page 165 on September 11, 1956.

Stephen A. Stokes died testate during 1966 and his will devised the property to his wife, Birdie Campbell Stokes for life and then to his sons, Stephen A. Stokes, Jr. and Lamont V. Stokes.

The property above described is conveyed subject to all restrictive covenants, setback lines, rights-of-way and easements of public record and appearing on recorded plat(s).
