situate, lying and being in the State of South Carolina, County of Greenville,
and in Greenville Township, on the East side of 9th Avenue, in Judson Mills
No. 2 Village, being known and designated as Lot No.2 of Block F as shown
on plat of Judson Mills No. 2 Village made by Dalton & Neves, Engineers, in
March 1939, which plat is recorded in the R.M.C. Office for Greenville County
in Plat Book K, at pages 1 and 2, and having, according to said plat, the

BEGINNING at an iron pipe on the East side of 9th Avenue, joint corner of
