ALL OUR RIGHT, TITLE AND INTEREST, IN AND TO THE FOLLOWING DESCRIBED PROPERTY LOCATED IN THE COUNTY AND STATE AFORESAID:

(1) All that certain piece, parcel or tract of land shown on a plat of James P. Strickland, Reg. L.S. #4042 dated April 6, 1978, said plat being recorded in the RMC Office for Greenville County in Plat Book 6-5 at Page 95 and according to said plat found to contain 6.29 acres, more or less, said property having the courses and distances, metes and bounds as upon said plat appear which are hereby incorporated and made a part of the description hereto by reference. Said property being bounded on the west by lands by lands of Carey C. Martin on the north by lands now or formerly of Charles H.
