Brooks," made by Dalton & Neves Co., June 1978, and having, according to said plats, the following metes and bounds: Beginning at an iron pin on the southwest side of Oak Street, joint front corner of Lots 22 and 23 and running thence with the southwest side of Oak Street N. 20-00 W. 40 feet to an iron pin, joint front corner of Lots 23 and 24; thence with Lot 24 S. 68-25 W. 121.15 feet to an iron pin of the rear line of Lot 3; thence with the rear lines of Lots 3 and 4 S. 38-03 E. 40.2 feet to an iron pin; rear corner of Lot 22; thence with Lot 22 N. 68-25 E. 115.5 feet to the point of beginning.
