the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto Helen Diamant, her heirs and assigns forever:

All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, being shown and designated as Lot 41 and a part of Lots 32 and 42 on plat of Eastgate Village Subdivision made by Piedmont Engineers and Architects, May 15, 1973 and recorded in the RMC Office for Greenville County in Plat Book 4-X At Page 31 and according to a more recent plat of Lot 41 and parts Lots 32 and 42, Eastgate Village made by Freeland and Associates, November 30, 1978 and recorded in the RMC Office for Greenville County in Plat Book 6-X at Page 88. According to said last mentioned plat the property is more fully described, inclusively, as follows:

Beginning at an iron pin on Blackenridge Drive at the joint front corner of Lots 40 and 41 and running thence along the joint line of said Lots, N 67-00 W 100 feet to an iron pin in the line of Lot 33; thence with the line of Lot 33, N 32-35 E 30 feet to an iron pin at corner of Lot 32; thence with new line through Lot 32, N 25-33 E 78.7 feet to a new iron pin; thence with new line through Lot 42, S 72-41 E 83.1 feet to an iron pin on the turnaround of Blackenridge Drive; thence with the curve of turnaround S 49-50 W 19.7 feet to an iron pin at the corner of Lot 41; thence continuing with curve of said turnaround, S 17-25 W 25.0 feet to an iron pin; thence continuing S 13-40 E 30.0 feet to an iron pin on Blackenridge Drive; thence continuing with said Drive, S 26-00 W 50 feet to an iron pin, the point of beginning.
