release unto **Rosamond Enterprises, Inc., its successors and assigns forever:**

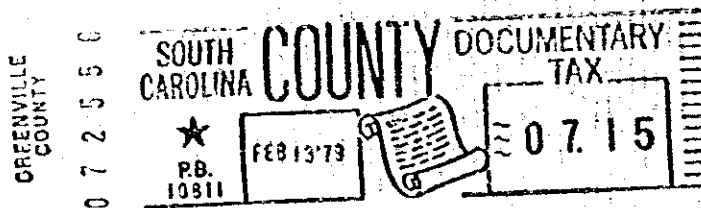
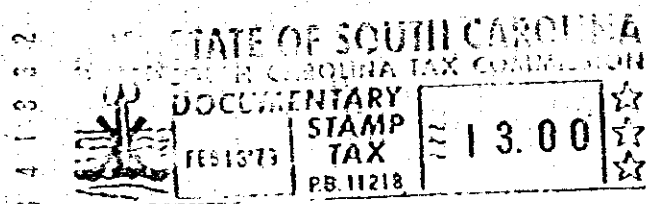
ALL that piece, parcel or lot of land in the County of Greenville,
