in the State aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

MASSEY-RICHARDSON DEVELOPERS, a Partnership, its successors and assigns,

ALL that certain piece, parcel or lot of land located in the County of Greenville, State of South Carolina, and lying and being on the northern side of Sunset Drive and being more particularly described according to a plat by T. H. Walker, Jr., dated July 29, 1977, as follows:

BEGINNING at an iron pin on the northern side of Sunset Drive, said iron pin being located 300.26 feet in a westerly direction from the intersection of Sunset Drive and U. S. Route 276 and running thence with the northern edge of Sunset Drive, S. 62-35 W. 100.26 feet to an iron pin; thence with the line of property now or formerly of Thomason, N. 27-25 W. 200 feet to an iron pin; thence N. 64-10 1/2 E. 100 feet to an iron pin; thence S. 27-30 E. 197.22 feet to an iron pin, the point of beginning.
