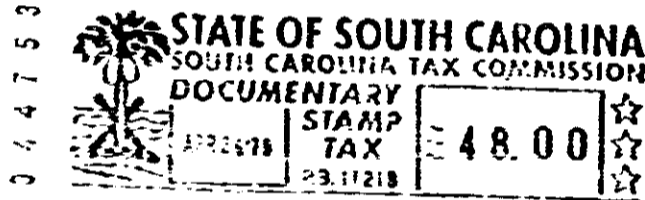
I. L. Donkle, Jr., his heirs and assigns forever:
