Dill, R. S., dated October 11, 1978, to be recorded herewith, and according to said plat, having the following courses and distances, to-wit:

BEGINNING at an iron pin in the center of a 25 foot easement that is 298 feet from Highway # 14, and running thence N. 35-26 W. 30 feet to a point; thence N. 33-20 W. 291 feet to an old iron pin; thence along the border of Howell, N. 65-15 E. 440 feet to an old iron pin; thence S. 20-00 E. 402 feet to an old iron pin; thence S. 78-33 W. 155 feet to an iron pin in the center of a 25 foot easement; thence S. 83-47 W. 179.6 feet to a point in the center of a 25 foot easement; thence S. 53-17 W. 38 feet to the point of beginning, and contains according to said plat, 3.24 acres, more or less.

This conveyance is subject to the 25 foot easement as shown on said plat.

The grantor herein does hereby reserve a life estate in the above property, for and during her natural lifetime.
