the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto FRED B. HAMILTON III, his heirs and assigns forever:

ALL of my undivided one-half interest in and to that certain piece, parcel or lot of land, with all buildings and improvements thereon, situate, lying and being on the northwestern corner of the intersection of Pettigru Street and Boyce Avenue, in the City of Greenville, Greenville County, South Carolina, being known and designated as Lot No. 6, Block 4, as shown on a plat entitled SUBDIVISION OF BOYCE LAWN ADDITION, made by J. T. Lawrence, dated April 2, 1908, recorded in the RMC Office for Greenville County, South Carolina, in Plat Book A at page 179 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin at the northwestern corner of the intersection of Pettigru Street and Boyce Avenue and running thence along the northwestern side of Boyce Avenue, N. 15 W. 126 feet and one inch to an iron pin on the southern side of a ten-foot alley; thence with the southern side of said alley, S. 76-45 W., 71 feet and 8 inches to an iron pin at the joint rear corner of Lots Nos. 5 and 6; thence along the common line of said lots, S. 15 E., 126 feet and one inch to an iron pin on the northern side of Pettigru Street; thence along the northern side of Pettigru Street, N. 76-45 E., 71 feet and eight inches to an iron pin, the point of beginning.
