ALL that piece, parcel or lot of land in Chick Springs Township, Greenville County, State of South Carolina, lying and being in the North side of Cuttino Road, being shown as Lot 15 and a portion of Lot 16 of Block "B" on Plat of Property of Realty Corporation, recorded in the RMC Office for Greenville County, South Carolina, in Plat Book "C" at page 86 and 87, and having according to said Plat, the following metes and bounds, to-wit:
