

N 87° 40' W 400 feet to a point; thence turning and running along the rear of two tracts of land (7.55 acres, more or less, and 7.10 acres, more or less) N 12° 30' W 435.7 feet; N 12° W 434.5 feet to a point; thence turning and running N 82° 50' E 600 feet to a point on the westerly side of Geer Highway; thence running along the westerly side of said Geer Highway the following courses and distances: S 22° 10' E 100 feet; S 47° 10' E 400 feet; S 2° 10' E 100 feet; S 17° 20' W 300 feet; S 16° 20' W 200 feet; S 23° 40' E 100 feet; S 43° 40' E 100 feet; S 51° 25' E 500 feet; S 50° 50' E, crossing said alley or driveway, 120 feet to the point of beginning.

(4) ALSO that lot of land situate on the northeasterly side of Geer Highway, containing 1.09 acres, and having according to said plat the following metes and bounds, to wit:

BEGINNING at a point on the northeasterly side of Geer Highway and running thence N 42° 40' E 400 feet to a point; thence turning and running S 42° 30' E 138.6 feet to a point; thence turning and running S 48° 10' W 400 feet to a point on the northeasterly side of said Geer Highway; thence turning and running along said highway N 14° 50' W 100 feet to the point of beginning.

(5) All that piece, parcel or lot of land situate on the southeasterly side of the Geer Highway (U.S. 276), being shown as Tract 5 on the plat first above referred to, recorded in Plat Book 7-G, Pages 4-5, and also shown on plat of property designated as Section A, Caesar's Head Development, recorded in Plat Book 7-G, Page 6, and having according to said latter plat the following metes and bounds, to wit:

BEGINNING at a point on the southerly side of the Geer Highway and running thence along the southerly side of said highway, at the Northeast corner of the 15.27 acre tract, the following courses and distances: S 82° 45' E 325.0 feet; N 61° 30' E 132 feet; thence turning and running S 35° 20' E 50 feet; thence turning and running N 54° E 160 feet (to a driveway entrance near an old store); thence turning and running N 17° 30' E 52.5 feet to a point on the southeasterly side of the Geer Highway; thence turning and running along the southeasterly side of said highway N 54° 40' E 785 feet to a point; thence continuing along the southeasterly and easterly side of said highway the following courses and distances: N 20° 30' E 115.5 feet; N 14° 45' W 100 feet; N 42° 15' W 100 feet; N 41° 30' W 175 feet; N 18° 45' E 50 feet; N 55° 45' E 50 feet; S 72° 30' E 75 feet; S 51° 00' E 100 feet; S 46° 00' E 100 feet; S 35° 30' E 100 feet; S 33° 30' E 100 feet; S 31° 30' E 100 feet; S 31° 30' E 100 feet; S 62° 10' E 310 feet; S 79° 40' E 100 feet; N 76° 10' E 100 feet; N 21° 00' E 105 feet to a point; thence turning and leaving said Geer Highway and running S 26° 45' E 90 feet to a point; thence turning and running N 82° 00' E 146 feet to a point (at the northeasterly corner of Lot 98 (22)); thence turning and running S 8° 00' E 151.5 feet to a point; thence S 20° 00' W 400 feet to a point; thence S 0° 5' E 482.7
