release unto SELINA D. WOOD and NARAYAN L. NAIK, their heirs and assigns forever:

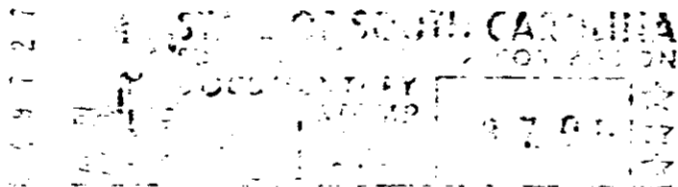
ALL that certain piece, parcel or lot of land in the Town of Simpsonville,
