and release unto GORDON C. CARTER, his heirs and assigns, forever:

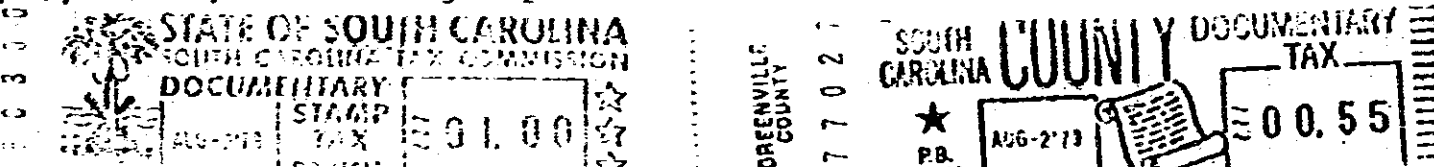
