the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

SOUTH CAROLINA NATIONAL BANK, as Trustee under the Will of William H. Richardson, deceased, for the benefit of Eleanor R. Bishop, its successors and assigns forever:

AN UNDIVIDED 1/6 INTEREST IN AND TO:

ALL that certain parcel or tract of land situate on the Northeast side of Washington Avenue and on the Southeast side of Valley Street, near the City of Greenville South Carolina, being shown as a portion of Westview on plat thereof made by C. M. Furman, Jr., Engineer, and recorded in the RMC Office for Greenville County, S.C., in Plat Book F at Pages 139 and 140, and having, according to a recent survey made by Dalton & Neves, Engineers, June, 1955, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southeast side of Valley Street, said pin being located 25 feet in a Southwesterly direction from the corner of Lot 133 as shown on plat of Westview referred to above, and running thence down the center of what was formerly Walker Street (now abandoned), S. 45-44 E., 119.1 feet to an iron pin thence N. 44-16 E., 175 feet to an iron pin at the joint rear corner of Lots 134 and 135 as shown on plat of Westview referred to above; thence S. 46-34 E., 235 feet to an iron pin; thence S. 44-16 W., 309 feet to an iron pin on the Northeast side of Washington Avenue; thence along the Northeast side of Washington Avenue, N. 26-50 W., 374.1 feet to an iron pin at the present Southeast corner of the intersection of Washington Avenue and Valley Street; thence along the Southeast side of Valley Street, N. 43-33 E., 9.3 feet to the beginning corner.

ALSO AN UNDIVIDED 1/3 INTEREST IN AND TO:

ALL that piece, parcel or lot of land, situate, lying and being on the corner of West Street and Butler Avenue, in the City of Greenville, in the State of South Carolina, beginning at said corner and running thence S. 18 W., 150 feet in Butler Avenue to a stake, corner in lot of J. B. McIntosh; thence S. 64 1/2 E., 75 feet along said J. B. McIntosh line to a stake, corner of J. A. McCullough lot; thence N. 18 E., 150 feet along said McCullough's line to a stake on West Street; thence along West Street N. 64 1/2 W., 96 feet to the beginning corner.
