the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Ralph B. Whisnant and Cheryl C. Whisnant, their heirs and assigns, forever:

All that certain piece, parcel or tract of land, with all improvements thereon, situate, lying and being in Greenville County, South Carolina, near the Town of Simpsonville, containing 5.85 acres according to a plat thereof entitled "Property of B. F. Reeves" prepared by C. O. Riddle, Registered Land Surveyor, dated November 23, 1973, revised December 19, 1973, recorded in the RMC Office for Greenville County in Plat Book 7-R at page 27, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING an an iron pin on the western side of the cul-de-sac at the northern end of White Pine Drive, and then leaving White Pine Drive and running N. 62-22 W., 612.5 feet to an iron pin; thence S. 81-23 W., 236.4 feet to an old iron pin near a branch with the center line of the branch as the property line; thence with the center line of said branch the traverse of which is N. 38-18 W., 121.7 feet to an old iron pin; thence continuing with the center line of the branch the traverse of which is N. 55-58 W., 120.4' to an old iron pin; thence continuing with the center line of said branch the traverse of which is N. 68-35 W., 102.7 feet to an old iron pin on the line of property now or formerly owned by the Town of Simpsonville; thence with the line of said property, N. 21-02 E., 385.1 feet to an old iron pin; thence continuing with the line of said property, N. 18-46 E., 264.5 feet to an old iron pin; thence leaving the line of said property and running N. 72-34 E., 113.6 feet to an iron pin; thence, S. 12-15 E., 797.1 feet to an iron pin; thence S. 62-22 E., 611.2 feet to an iron pin on the western side of the cul-de-sac of White Pine Drive; thence with the curvature of the cul-de-sac of White Pine Drive, the traverse of which is S. 8-34 E., 30.98 feet to the point of beginning.
