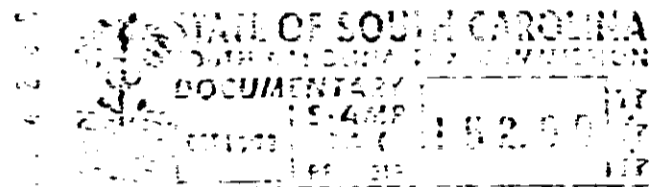
KNOW ALL MEN BY THESE PRESENTS, that WE, RALPH W. POPE and BARBARA S. POPE
