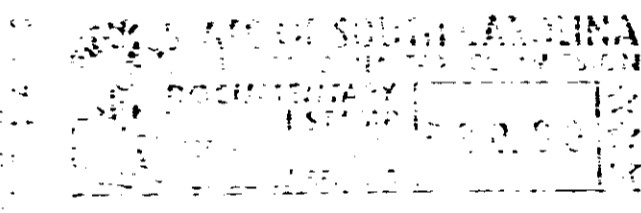

BEGINNING at an iron pin on the Southern side of University Ridge which pin is 120 feet in an easterly direction from Cleveland Street and running thence along the southern side of University Ridge N. 71-50 E. 43.7 feet to an iron pin at the corner of property of University Ridge Homes, Inc., thence S 22-20 E. 103 feet to an iron pin, thence S. 64-40 W. 20.6 feet to an iron pin; thence N 55-33 W. 69.1 feet along the northeast edge of an alley to an iron pin; thence continuing along the eastern edge of said alley N. 12-54 W. 54.6 feet to an iron pin at the point of beginning.
