in consideration of the sum of Twenty-Seven Thousand One Hundred Fifty and No/100 (\$27,150.00) DOLLARS,

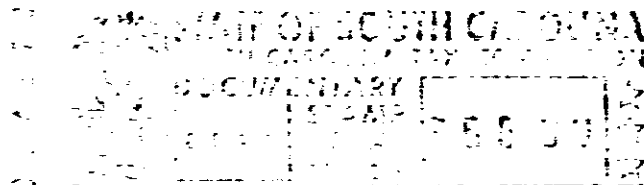
