WILTON M. NASH AND IDA LEE NASH, as joint tenants with rights of survivorship and not as tenants in common,

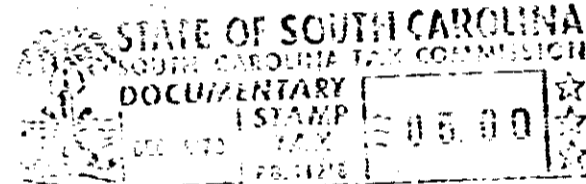
