BEGINNING at an iron pin on the easterly side of Crestwood Drive, which iron pin is 155 feet in a northerly direction from the corner of the intersection of Garden Terrace and Crestwood Drive, at the northwestern corner of property heretofore conveyed to Mozelle M. Landers, and running thence along the easterly side of Crestwood Drive, N. 27-30 E. 180 feet to an iron pin in the line of other property formerly owned by J. LaRue Hinson; thence along the line of said Hinson property, S. 62-30 E. 200 feet to an iron pin in the line of other property of Hinson; thence along the line of said Hinson property, S. 27-30 W. 180 feet to an iron pin at the northeast corner of the said Landers lot; thence along the line of said Landers lot, N. 62-30 W. 200 feet to an iron pin in the line of Crestwood Drive, the point of beginning.
