THE COURT OF COMMON PLEAS

To All Whom These Presents Shall Come:

I, FRANK P. McGOWAN, JR., as Master in and for the County aforesaid, SEND GREETING:

WHEREAS, Loyd A. Smith

on or about the 7th day of January in the year of our Lord nineteen hundred and eighty exhibited his

complaint in the Court of Common Pleas for the County aforesaid, against Georgia S. Hudson, Sue S. McCall, Kay S. Siau, Mrs. Ruby McCall Walker, Ronnie Ray McCall; Harvey William Hudson Jr., a minor over the age of fourteen (14) Years, Timothy Mark McCall, a minor under the age of fourteen (14) years, Georgia S. Hudson as representative of unborn children of Loyd A. Smith and Ronnie Ray McCall as representative of unborn grandchildren\* demanding relief as to the real estate described in the complaint and the cause being at issue, came on to be heard \*of Loyd A. Smith on the 26th day of March 1980,

and such proceedings were had therein as resulted in a decree of the said Court, whereby it was adjudged and decreed that the said real estate hereinafter mentioned and described, be conveyed by FRANK P. HAVE GRANTED, conveyed and released, and by these presents, DO GRANT, convey and release unto the said Robert L. Ware and Jacqueline C. Ware:

ALL that certain piece, parcel or tract of land, with all improvements thereon, or hereafter constructed thereon, situate lying and being in the State of South Carolina, County of Greenville, and being shown on plat entitled "Loyd A. Smith Life Estate, Tract 4" as prepared by Freeland & Associates dated October 24, 1979, as recorded in the RMC Office for Greenville County, South Carolina in Plat Book 7W, Page 73, and having according to said plat the following metes and bounds to-wit:
