ALL OUR RIGHT, TITLE AND INTEREST, THE SAME BEING AN UNDIVIDED TWO-THIRDS INTEREST, IN AND TO THE FOLLOWING DESCRIBED PROPERTY:

ALL that piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville on the Southwest side of Boling Road, being shown and designated as Lot 19 on plat of PLANTATION ESTATES, Property of Dempsey Real Estate Company, Inc., made by Campbell & Clarkson, Surveyors, Inc. dated December 16, 1971 and recorded in the R.M.C.
