OF GREENVILLE its successors and assigns forever the following described property, to-wit:

ALL that certain piece, parcel or lot of land, with all improvements thereon or hereafter constructed thereon, situate, lying and being on the western side of Augusta Street in the City of Greenville, County of Greenville, State of South Carolina, being shown and designated according to plat made by Dalton & Neves, Engineers, dated June 1951, and revised July 1964, to-wit:
