

(2) ALL that certain piece, parcel or lot of land situate, lying and being on the western side of Buncombe Street, in the City of Greenville, County of Greenville, State of South Carolina, having the following metes and bounds:

BEGINNING at an iron pin on the western side of Buncombe Street 71 feet southeast from the property formerly owned by Dr. Stone, corner of Gilreath property; thence S. 56-06 W. 131.5 feet to an iron pipe; thence along the line of property formerly owned by Gilreath S. 39-46 E. 15 feet to an iron pipe; thence continuing with the line of the Gilreath property S. 48-30 W. 55.6 feet to a point on a 12-foot alley; thence along the eastern side of said alley S. 69-32 E. 26.7 feet to iron pipe, corner of property of J. Roe, and running thence with the line of said property S. 62-53 E. 75.2 feet to a fence post; thence continuing with the line of said property S. 36-45 E. 34.4 feet to a fence post, corner of other property of T. A. Roe; thence continuing with the line of other property of T. A. Roe S. 22-55 W. 54 feet to a fence post, corner of property now or formerly owned by Stribling; thence with the line of said property N. 64-26 W. 105.3 feet to an iron pin on North Academy Street; thence with the eastern side of said street N. 26-0 E. 71.7 feet to the point of beginning.
