Stone, Jr., of the County of Greenville, in the State aforesaid, the receipt and sufficiency whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Ward S. Stone, Jr., all my right, title and interest in and to the following described property, to-wit:

All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, and in Ward Two of the City of Greenville on the west side of Rowley Street, and being known and designated as the northern half of Lot No. 38 of a subdivision of the property of the Stone Land Company as shown on plat thereof made by J. E. Sistine and Company as recorded in the RMC Office for Greenville County in Plat Book A, at Page 339, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the west side of Rowley Street in the center of the front line of Lot No. 38 at the corner of the lot now or formerly belonging to Lucy C.
