EXTENSION
OF
TRUST AGREEMENT

This Extension of Trust Agreement made and entered into as of this 19th day of June, 1980, by and between T. M. BAILEY, SOUTH CAROLINA NATIONAL BANK as Executor of the Estate of MARVIN P. CANNON, SR., Deceased, HAZEL H. CANNON, H. BAXTER CARPENTER, WACO F. CHILDERS, JR., TRUST COMPANY OF FLORIDA, Personal Representative of PAUL A. GUTHRIE, Deceased, W. GAINES HUGULEY, ARTHUR C. McCALL, SOUTHERN BANK AND TRUST COMPANY, as the Executor of the Estate of WAKE H. MYERS, HARRY R. STEPHENSON, JR., J. ROBERT THOMASON and BANKERS TRUST OF SOUTH CAROLINA and ELIZABETH W. WALKER as Co-Trustees under the Will of C. DOUGLAS WILSON, (hereinafter "Beneficiaries") and SOUTHERN BANK AND TRUST COMPANY, Greenville, South Carolina (hereinafter "Trustee"):

WITNESSETH:

WHEREAS, the undersigned "Beneficiaries" or their predecessors in title have heretofore entered into a Trust Agreement dated November 18, 1969, with Southern Bank and Trust Company, Greenville, South Carolina, as "Trustee"; and

WHEREAS, the "Beneficiaries" or their predecessors in title by deed dated November 18, 1969, and recorded in the RMC Office for Greenville County, South Carolina, in Deed Book 879 at page 489, were conveyed certain real property in the name of Southern Bank and Trust Company as Trustee under the aforementioned Trust Agreement; and

WHEREAS, on November 6, 1979, Paul A. Guthrie, a beneficiary under said Trust Agreement, died testate in Orange County, Florida, and Trust Company of Florida is the duly appointed and acting personal representative of Paul A. Guthrie as appears in the records of the Orange County, Florida, Probate Division at File 79-1929;

WHEREAS, on December 12, 1979, Wake H. Myers, a beneficiary under said Trust Agreement, died testate in Greenville County, South Carolina, and Southern Bank and Trust Company is the duly appointed and acting executor of the estate of Wake H. Myers, as appears in the records of the Probate Court of Greenville, South Carolina at Apartment 1588, File 13;

WHEREAS, on May 3, 1974, Marvin P. Cannon, Sr., did assign one-half (1/2) of his beneficial interest in said Trust over to Hazel H. Cannon;
