48 and 49.

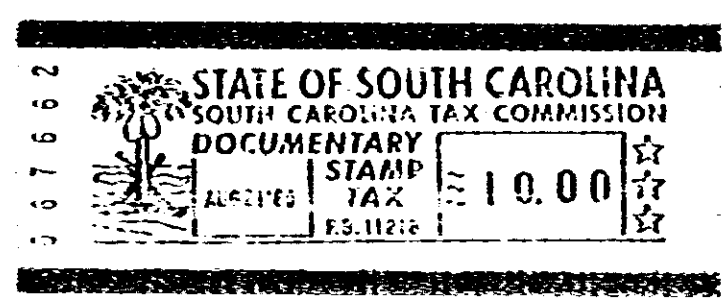
