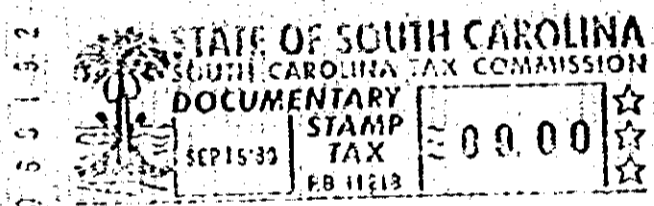
in consideration of Four Thousand Three Hundred Seventy-five and no/100 (\$4,375.00) Dollars,
