

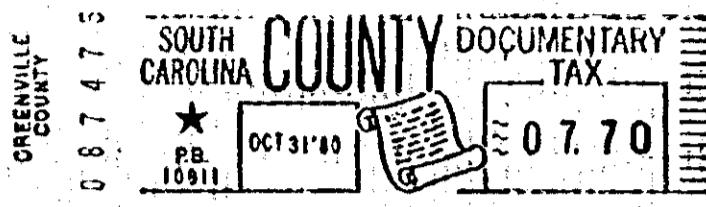
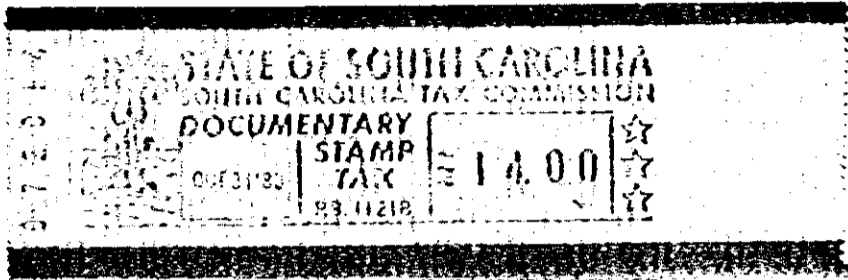

KNOW ALL MEN BY THESE PRESENTS That TROLLINGWOOD REALTY COMPANY,
partnership formed
a corporation organized under the laws of the State of South Carolina
and having its principal place of business at Greenville
in the State of South Carolina for and in consideration of the
sum of Seven Thousand and No/100 (\$7,000.00)-----

to it in hand duly paid at and before the sealing and delivery of these presents by the grantee(s) hereinafter named (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto Frank B. Halter, his heirs and assigns, forever:

All that piece, parcel or lot of land situate, lying and being on the Northern side of Shadowmere Drive, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 39 as shown on a plat entitled "Trollingwood, Section I", prepared by Enwright Associates, dated September 30, 1971, and revised February 6, 1979, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book 6-II at page 98, and having, according to the last mentioned plat, the following metes and bounds:

BEGINNING at an iron pin on the Northern side of Shadowmere Drive at the joint front corner of Lots Nos. 38 and 39, and running thence with the line of Lot No. 38 N. 25-22 W. 229.7 feet to an iron pin at the normal pool line of a lake known as Lake Trollingwood; thence with the normal pool line of said lake N. 67-24 E. 165.5 feet to an iron pin at the joint rear corner of Lots Nos. 39 and 40; thence with the line of Lot No. 40 S. 24-00 E. 226.2 feet to an iron pin on the Northern side of Shadowmere Drive; thence with the Northern side of Shadowmere Drive S. 66-12 W. 160 feet to the point of beginning.

This is the identical property conveyed to the Grantor herein by deed of R. B. Landers, et al., dated December 10, 1970, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Deed Book 906 at page 390 on January 15, 1971.

This conveyance is subject to all restrictions, zoning ordinances, setback lines, roadways, easements and rights of way, if any, affecting the above described property, including restrictions applicable to Trollingwood, Section I, recorded in the R.M.C. Office for Greenville County, South Carolina, in Deed Book 906 at page 400.
