G. MITCHELL GAULT, HIS HEIRS AND ASSIGNS FOREVER, ALL OF MY INTEREST, SAME BEING AN UNDIVIDED ONE-SIXTH (1/6) INTEREST IN AND TO:

ALL the following described tract or parcel of land together with all improvements located thereon situate in the City of Mauldin, County of Greenville and State of South Carolina, and being more particularly bounded and described as follows:

BEGINNING at the point of intersection of the southerly line of Edgewood Drive with the westerly line of U. S. Highway No. 276 and running thence S. 4-43 E., 99.8 feet to an iron pin on line of property conveyed by Ashland Oil, Inc. to Waffle House, Inc. on March 11, 1974; thence with the line of Waffle House, Inc. 72-50 W., 200.0 feet to an iron pin; thence S. 4-43 E., 70.0 feet to an iron pin; thence N. 72-50 E., 30.0 feet to an iron pin; thence S. 4-43 E., 250.0 feet to a point in the north line of Mauldin Tire and Alignment Company; thence S. 72-50 W., 143.9 feet along the north line of Mauldin Tire and Alignment Company to an iron pin on the edge of a 20 foot alley; running thence down the eastern side of said alley N. 17-10 W., 284.7 feet to a point on the edge of said alley; thence continuing down the alley N. 6-53 W., 209.2 feet to a point at the intersection of the alley and Edgewood Drive; running thence down the southern side of Edgewood Drive N. 85-08 E., 375.9 feet to the point of beginning.
